

## 2022 State of Vermont Flu Clinic Directions

**BARRE / Barre City Place -219 North Main Street, Barre**: VTrans Conference Room 134-1<sup>st</sup> Floor. In Barre Center. State entrance is on right side of building. *Metered street parking or city parking across street behind stores. State parking lot is further back across railroad tracks in permit area. No permit required to park.* 

BARRE / McFarland Building - 5 Perry St., Barre: VDH WIC Clinic, 2<sup>nd</sup> Fl. Off Rte. 302 (Washington St.) near intersection of Rte. 302/14 in Barre Center. *Driveway loops up left and around building*. *Park behind building*.

**BENNINGTON / AOT - 359 Bowen Rd., Bennington:** From Rte. 7, turn onto Kocher Dr. (shopping plaza on right). Take first right onto Park St., then left onto Bowen Road. AOT is on right before sharp left turn.

**BENNINGTON / Family Services - 200 Veteran's Memorial Drive, Bennington:** Located off Rte. 7 between the Veteran's Hospital and the park. Cow statues in front. Same building as Courthouse. Clinic is in the Family Services Conference Room, 3rd floor. **Leave extra time for security screening d/t courthouse.** 

**BERLIN/ VTrans Training Center - 1716 US Rte. 302, Room 114A, Berlin:** On Rte. 302, between Wayside Diner and 1-89 access road, on opposite side of street. Main entrance faces Route 302. *Entrance door to clinic is at the back of the building at the top of the ramp.* You can park within the Central Garage gated area or use the parking lot at the 1<sup>st</sup> left off Partridge Road by CVS. Walk across small bridge to the building and enter through the gate on the left of the building.

**BERLIN/ Dill Building – 2178 Airport Road, Berlin:** Take exit 7 off I-89 and merge onto VT-62 toward Berlin/Barre/Route 302. Turn right on Airport Road (1.8 miles). Look for main airport building on right side of road. VTrans entrance is directly across the street, first building on left as you enter gated area. Clinic will be in large conference room through main entrance.

**BRATTLEBORO / State Office Complex, 232 Main St. Brattleboro: Room 148 A & B** Located where Main Street and Linden Street intersect. *Across parking lot from former Police Station. Metered parking along building or on Main St. Enter parking lot by taking right on Grove Street and right onto access driveway. Past building on left to enter left driveway to state parking area.* 

**BURLINGTON** – **108 Cherry St., Burlington:** Turn onto Cherry Street from Battery Street. Building is on left side after St. Paul and before Church Streets. Clinic is in 2<sup>nd</sup> floor conference rooms. *Parking available at street meters or in parking garages*.

**COLCHESTER / AOT – 189 Troy Ave., Colchester:** From Rte. 15 (College Parkway), turn onto Barnes Ave. (Fort Ethan Allen) at traffic signal. Take right on Troy Avenue and left into first gate. AOT building is first building ahead on right.

**DERBY AOT - 4611 US Rte. 5 (Derby Rd.), Derby:** On Rte. 5, next to State Police across from McDonalds, Dunkin Donuts and Modern Furniture and Bedding store.



**DUMMERSTON/ AOT District 2 - 870 US Rte. 5, Dummerston:** I 91, Exit 3, turn northeast and go 3 miles on US-5 N/ Calvin Coolidge Memorial Hwy/ Putney Road. Destination is on the right.

**ESSEX JCT / Forest & Wildlife – 111 West St.,** Act 250 Conference Room. From 5 Corners in Essex Jct., head 0.3 miles Southwest on Rte. 2A (Park Street) toward Park Terrace. Turn right onto South St. In 0.2 miles continue straight onto West St. The destination will be on your right in 0.6 miles.

**MENDON AOT -Route 4- 61 Valley View, Mendon:** From Merchants Row in Rutland, travel 3.5 miles east on Rte. 4. Go 0.3 miles past Best Western and Rocking Horse Country Store (across from Casella's) and turn left onto Valley View (private road). AOT is first building on left (formerly the Peace of Mind Emporium). *Entrance for clinic will be through handicap entrance around back of building*.

MIDDLEBURY / State Office Complex - 156 Court Street (South Village Green), Middlebury: Off Court St. (US Rte. 7), across parking lot from Peoples United Bank. Clinic is in 1<sup>st</sup> floor conference room on the right off hallway.

MONTPELIER / Tax Building - 133 State Street, Montpelier: Tax building is located on same side of street as Capitol near Bailey Ave. Handicap access in rear of building. Metered parking on street. Bring photo ID for security access and leave extra time for security clearance.

MONTPELIER / National Life - 1 National Life Dr., The Davis Building (formerly North Lobby Entrance), Montpelier: I-89, exit 8; from Memorial Dr., turn onto National Life Dr. at light. Take 2nd left into main entrance. Drive halfway down parking lot. Entrance is on the left; clinic is on the 5<sup>th</sup> Floor. Turn right off elevator to N-513. Visitor parking limited. Bring photo ID for security access and leave extra time for security clearance.

**MORRISVILLE / State Office Complex - 63 Professional Drive, Morrisville:** Professional Dr. is off Rte. 100 across from Northgate Plaza Shopping Center. The State Office Complex is first building on left. Clinic is in Human Services Conference Room.

**NEWPORT / Emory Hebard State Office Building - 100 Main St., Newport:** Located at intersection of Main and Coventry Streets. Clinic in the 2<sup>nd</sup> Floor Large Conference Room. *Park in the side parking lot at ground floor level.* 

**RUTLAND / ASA BLOOMER Building - 88 Merchants Row, Rutland:** Located in downtown Rutland, on corner of Center and Evelyn St. Clinic is on second floor in room 266. *Metered parking available on street or in rear parking garage. Also, can park across street in Walmart Parking lot.* 

**SPRINGFIELD / State Office Complex - 100 Mineral St., Springfield:** Take Rte. 11 (called Chester Rd., Clinton St. and Main St.) to intersection of Mineral St. in Springfield at traffic light. Turn onto Mineral St., cross over bridge. State complex is first building on left. *Park in lower lot*.



- **ST. ALBANS / AOT– 680 Lower Newton Road:** From Route 7 (North Main Street) head north toward Upper Newton St; take the 1<sup>st</sup> left onto VT 38/ Lower Newton Rd. and go 0.7 mile; the AOT Office is on the left in the white building.
- **ST. ALBANS / State Office Complex 27 Federal Street, St. Albans:** From Rte. 7 (Main Street), turn onto Lake Street (VT-36) and right onto Federal St. Location is on your right. Clinic is in 1<sup>st</sup> Floor Conference Room
- **ST. JOHNSBURY AOT, 1068 US Rte. 5, St. Johnsbury:** Located on Rte. 5, .25 mile from Rte. 91, in the same building as State Police.
- **ST. JOHNSBURY / State Office Complex 107 Eastern Ave., St. Johnsbury:** Located two blocks from Route 5 on Route 2, near the intersection of Eastern Avenue and Park Street. Clinic in VDH Conference Room.

**WATERBURY / Waterbury Complex:** Follow Route 100 and Route 2 into the town of Waterbury, turn right onto Park Row. Go straight through stop sign and follow road around complex. Main entrance is in back center of building. Stone plaza with flagpoles. *Bring photo ID for security access and leave extra time for security clearance.* 

WHITE RIVER JUNCTION / AOT - 223 Beswick Dr., White River Junction: From Rte. 5, turn onto Sykes Ave. (McDonald's is on the corner). Immediately turn right off Sykes Ave. (as though you were turning into McDonald's) onto Beswick Dr. Follow Beswick Dr. to end, bear right at fork, through gate at end of road. Clinic is in the second (new) building on the right past gate.

WHITE RIVER JUNCTION / State Office Complex, 118 Prospect Street, 1st Floor Conference Room, White River Junction

North on US 5/US-5N and follow Blake Dr. Turn left on Hartford Ave/US-5N/US-4E, then turn right onto Maple St./US-4E/VT-14, then turn left onto Prospect St.
