- Get involved with your community! Volunteer to clean up streams, pick up trash, plant trees, etc.

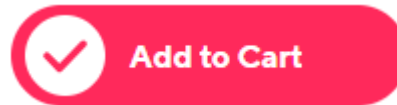
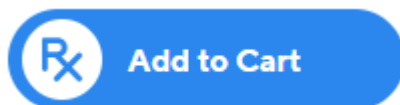
